# CONDITIONS OF ENTRY

1. This Exhibition is open to anyone, however, an entry may be rejected when the sponsoring organization or its agent, in its reasonable discretion, believe the entry does not conform to the rules of the exhibition. Accepted entries are eligible for PSA's "WHO's WHO" and Star Ratings in their respective PPD Divisions.
2. Same or similar looking images cannot be entered by the same entrant in multiple sections.
3. Images accepted in this exhibition during any previous year cannot be entered in the same section. **We encourage entry of new and recent work.**
4. Each entry must be accompanied by the appropriate entry fee and the completed entry form.
5. Entry fee must be sent in US funds or checks in US Dollars made out to "MSP Print Circuit". All foreign checks, including Canada, please add \$15 for collection fee.
6. Care will be taken to protect all entries; however, MSP Print Circuit is not liable for loss or damage to the prints.
7. **PERMISSION TO COPY IMAGES FOR CATALOG OR OTHER PROMOTIONAL USE OF THE CIRCUIT IS ASSUMED, UNLESS OTHERWISE STATED.**
8. The original image must be made by the entrant and cannot incorporate elements made by others. Any modification of the original image must be made by the entrant. By virtue of entry, the entrants certify the work as their own and permit the sponsors to reproduce part or all of the entered material free of charge for publication in the catalog or other media related to the circuit. Due credit will be given to the author in each case of such use. The circuit assumes no liability for any misuse of copyright by the entrant.
9. Hand colored prints are allowed in color sections.
10. An entrant can enter 4 images in each section. Fee structure is based each section. The entry will be distributed throughout 4 rounds of judging.
11. One split entry is allowed after 3 judgings. Additional fee applies for split entry.
12. Maximum size limitations including mount:  
Class A: Up to 16 x 20 inches  
Class B: Up to 8 1/2 x 12 inches
